

# Policy BUDDIES – BUilding Demand for evidence in Decision making through Interaction and Enhancing Skills

Situational analysis (baseline assessment)

Capacity development

 Enhancing capacity to identify various research questions and drawing on systematic reviews to inform refinement of their questions

Buddies

 Support policymakers in making decisions related to research through a buddy model, and providing opportunities for dialogue.

Resources

 Package and make dedicated resources available to guide policymakers and provide links to relevant researchers.

Monitoring and evaluation



#### Strategies to enhance research use



Policymakers to understand the importance of research and its role in policies Importance of joint efforts between researchers and policymakers

Researchers to understand the policy environment

Situational analysis: Programme managers emphasised the importance of **joint efforts** between researchers and policymakers - **working together** with mutual trust and understanding each other's environments


#### **Buddies**

A 'buddying' model to create links between policy-makers and researchers around specific priority policy questions.

#### **Evaluation**

- Mixed-methods
- Evaluation data and methods:
  - document review of policy and project documents,
  - in-depth interviews with policy-makers and project staff, and
  - a focus group discussion with researcher buddies.
- To describe how the intervention was implemented, barriers and successes during its implementation and uptake, and learning strategies developed during this process.
- To describe the impact of the intervention on policy-makers' use of research evidence to inform their decision-making.

### Lessons learnt: evaluation

#### Flexibility

Buddying taught me that when engaging with policymakers about evidence, one needs to be flexible and depending on the nature and format of the engagement, one needs to try and find the most feasible mode of communicating the evidence.

Researcher buddies benefited in learning about the policy-making world

We don't have their capacity/skills and they don't have ours. The linkage is the key to make the process smoother.

 Engagement helped researchers understand that systematic review evidence is only a piece of the complex policymaking puzzle.

As a buddy, I learnt that we have much to learn about decision-making in our government environment

#### Lessons learnt: evaluation

- Having policymakers who **champion** the use of evidence appears to facilitate 'buddying'.
- Buddying can be time-consuming and wanes when champions leave posts.

It takes a lot of time just to talk and build relationships. One week for example I felt I didn't get any work done, because all I did was talk. But actually I did because I was building relationships.

#### Spin offs

Additional linkages we have made are a big success. We are now getting additional requests from other policy-makers who were not involved in the project. So our network has expanded through our collaboration with policymakers in the project.

#### In conclusion

- Relationships open the door to mutual respect and learning.
- Researcher buddies benefited in learning about the policy-making world.
